



# Non-profit Family Planning Services Organization Selects FirstLight for SD-WAN Solution

## CHALLENGE

Since 1971, Maine Family Planning's mission has remained the same: to provide Maine residents with access to affordable, high-quality reproductive healthcare

and education. While the values and commitment that lay at the core of Maine Family Planning's purpose have not changed,



its operations and network of facilities have evolved significantly over the years.

With its headquarters in Augusta, ME, Maine Family Planning has grown to include 18 care facilities across the state, spanning from Fort Kent to Calais to Norway, Maine. These facilities were acquired over the course of the organization's 50+ years in business, each coming with its own unique technology, equipment, and connectivity. As these disparate environments multiplied with the addition of new sites, Maine Family Planning became increasingly aware that its infrastructure needed an overhaul, as well as support to efficiently manage it all.

# SOLUTION

Maine Family Planning conducted an IT assessment across its locations, engaging an IT consultant to work alongside its team on an effective solution that would continue to grow with the organization. With uniformity and performance high on the list of requirements, as well as the need for deep visibility into technology across multiple sites and help managing that technology, all signs pointed to an SD-WAN solution.

# **RESULTS**

Maine Family Planning had 75% of its FirstLight SD-WAN solution in place when the COVID-19 pandemic swept the United States in March of 2020, with the remainder of its sites installed and serviceable by August 2020. Because of this, continuity of care via virtual services was not nearly as challenging as it would have been just months prior. Maine Family Planning's new robust network across all sites allowed it to deploy telehealth services as its primary mechanism to continue seeing patients throughout the turbulent months of the pandemic.

Post-pandemic, Maine Family Planning has integrated telehealth services as a standard practice, allowing providers to better leverage their resources, access more patients, and provide more consults, all while upholding its commitment to exceptional care. It has been able to bring on programs in new locations that it previously was unable to service.

Internally, Maine Family Planning's staff has experienced a substantial shift in the way they work, with more seamless Internet access across offices, an efficient, secure foundation to support the Electronic Health Record system, and plenty of bandwidth to access files where and when they're needed.

Maine Family Planning's new network and equipment have given stability to its IT environment, which will allow it to build upon the technology and services it now has in place and grow with the company.
