from MFP as the state's Title X family planning services grantee, including federally qualified health centers, school-based health centers, and Planned Parenthood affiliates in Maine.



* Thanks to changes at the state and federal level, family planning data collection is evolving to include more accurate reflection of gender diversity. We are working with our software systems and sub-grantees to incorporate these updates into our data and look forward to sharing a more detailed and accurate breakdown by gender in the coming years.



Annual submission of the Family Planning Annual Report (FPAR) is required of all Title X family planning services grantees for purposes of monitoring and reporting program performance. FPAR data are presented in summary form, which protects the confidentiality of individuals who receive Title X-funded services.

This annual reporting requirement is for family planning services delivery projects authorized and funded under the Population Research and Voluntary Family Planning Programs (Section 1001 of Title X of the Public Health Service Act, 42 United States Code [USC] 300; 42 CFR Part 59).



Reproductive Empowerment Project

MFP's Reproductive Empowerment Project (REP) was on a roll this fiscal year, as inperson outreach came back in full force and the need is greater than ever. REP's Outreach Coordinators worked with more than 75 organizational partners across the state to deliver sexual and reproductive health care and resources to folks who experience barriers to care due to substance use, domestic violence, housing status, incarceration and re-entry, and other obstacles.

Based on the observations of REP Outreach Coordinators, MFP applied for and received a \$15,000 grant from the John T. Gorman Foundation in June 2023 to purchase and distribute personal care kits and other essential supplies directly to people in need. REP is a fantastic example of a project that was piloted with private funds, that filled a critical safety net need, which once demonstrated could attract public funding to sustain its continued operation. Support from foundations and individuals drives outreach and innovation!

Community Engagement

Abortion Care

In April we filled a new position at MFP, a Volunteer & Community Programs Manager. We recognized that we need to nurture an enduring base of support that starts in the communities where we operate, and create opportunities for community members to connect to our clinics and our work yearround, not just during the legislative session or during moments of critical policy advocacy. Real relationships ground all of our work together.

We are so excited to see this program grow. One of the first projects we launched is a community-based Abortion Care Package assembly action. Participants across generations and life experiences gather together to assemble care packages for people who are receiving abortion care from Maine Family Planning.

Downeast WIC

Partnerships with **Healthy Acadia's Gleaning Initiative** allowed us to receive lots of fresh produce that was given to WIC participants on a first-come, first-serve basis – it was a successful program and plans to expand and streamline the program are already in the works.

The Farmer's Market Nutrition Program helped WIC participants spend \$2,890 at local farmer's markets and farmstands. In partnership with Maine SNAP-ED, our Nutrition Coordinator helped support 6 cooking classes geared towards young families and provided education and cooking tips for healthy meals.

WIC staff attended several Mano en Mano events to support seasonal workers and provide WIC benefits to those who were eligible and for whom transportation was an issue – we went to the fields!

Downeast WIC's 1st Annual Community Baby Shower was on September 17th, 2022. Seven organizations tabled and provided information and resources to approximately 30 families. Families could "shop" for valuable items to help them care for their infants (baby wash, wipes, diapers, diaper rash cream, etc), and supplies were given away to parents to optimize their success with breastfeeding / chestfeeding. (Outside of the reporting period, but the 2nd Annual Community Baby Shower in September 2023 was a huge success!)

Maine Families

This year Maine Families Hancock County went through the **Parents as Teachers***Quality Endorsement and Improvement Process, required every 5 years, and passed with flying colors. The Maine Families Hancock County Home Visiting program is recognized as a Blue Ribbon Affiliate!

Maine Families Hancock County closely collaborates with our Downeast WIC program and our Ellsworth clinic, which is one of three MFP sites to offer primary care services (the other two being Houlton and Presque Isle).



*Parents as Teachers (PAT) is a home-visiting parent education program that teaches new and expectant parents skills to promote positive child development and prevent child maltreatment. PAT offers services to parents with children up to age 5 with the goal of increasing parental knowledge of early childhood development, improving parenting practices, promoting early detection of developmental delays and health issues, preventing child abuse and neglect, and increasing school readiness and success.

Prevention Education



Excellence in Sexual Health Education award winners at the 2023 Comprehensive Sex Ed Conference.

For the first time since the pandemic, the Prevention Program offered both virtual and in-person professional development for Maine educators. A total of 155 attendees took part in the return of in-person curriculum trainings and our 17th annual Comprehensive Sex Ed Conference. An additional 120 participants joined online virtual trainings on a variety of topics including supporting sex education, engaging parents, providing queer-inclusive sex ed and strategies for providing sexuality education to people with intellectual and developmental disabilities. Prevention Education staff presented at two national conferences and a number of statewide professional conferences.

Schools and educators across the state faced challenges from a small, vocal minority of community members and parents opposed to inclusive, comprehensive sexuality education. MFP's Prevention Program responded by sharing resources and strategies to bolster what research tells us – that the majority of parents support school-based sex education for their children.

In-depth consultation and support on providing sexual health education was provided to 160 staff at 89 schools in Maine. This support took the form of:


- co-facilitating with and coaching educators;
- providing condoms, educational materials, and other supplies to schools;
- offering customized staff and teacher trainings on-site;
- connecting educators with lesson plans and resources;
- guest speaking; and
- assessing student learning.

Over 100 community and school-based education programs were delivered throughout the state, reaching 366 adults and 479 youth. An additional 161 youth participated in Making Proud Choices, a 9-module sexual health curriculum developed specifically for youth in community based settings. Through a targeted grant from Martin's Point, the Prevention Education team was able to create a much-needed lesson plan on navigating the changes of puberty and provide Puberty Kits with period products to 35 elementary schools.

Advocacy

In the first state legislative session since the overturning of Roe v. Wade, Maine advanced several pieces of legislation that protected and expanded access to abortion at the state level.

The following bills were enacted and signed into law:

LD 1343, "An Act to Protect the
Reproductive Freedom of Maine People
by Preempting the Field of Abortion
Regulation" prevents towns, municipalities,
etc, from enacting abortion bans that
contradict state law. This preemption
prevents the spread of so-called "sanctuary
cities for the unborn," a tactic of anti-abortion
activists that has gained traction in recent
years.

LD 616, "An Act to Protect Health Care Professionals Providing Reproductive Health Care Services" protects Maine health care providers from being penalized or dropped by malpractice insurance providers solely on the basis of providing abortion care.

LD 935, "An Act to Remove Barriers to Abortion Coverage in Private Insurance" prevents health insurance plans from imposing deductibles, co-payments, co-insurance, or other cost-sharing requirements on abortion care services.

LD 263, "An Act to Ensure Access to Health Care" requires that health care mergers and acquisitions requiring a certificate of need be subject to strict scrutiny with regards to how the proposed changes may impact access to full scope sexual and reproductive health care services, including abortion care.

LD 1619, "An Act to Improve Maine's
Reproductive Privacy Laws" updates
Maine's Reproductive Privacy Act to remove
gestational bans on abortion, makes updates
to data collection policy related to abortion
care, and removes criminal penalties that
applied only to the provision of abortion care
and no other health care procedures.

MFP's advocacy is an important pillar of work, and philanthropy from individuals and foundations is a major contributor to our success in moving the needle on reproductive health and rights at the state and national level.




Fiscal Year 2022 - 2023
